



18.10: Admission Process

As per MAKAUT norms, all students intending to pursue the under graduate programmes (BBA and BCA) in different Colleges/ Institute will have to appear and qualify in the Common Entrance Test (CET).

All selected students are required to register with MAKAUT at the beginning of the course. At the time of registration students will also be required to submit the relevant documents/ testimonials and to give an undertaking to abide by the regulations of the college/ university, pay their fees in time as well as an Anti-Ragging undertaking.

The students also have to purchase the prospectus and admission kit of the college on payment of Rs.1200/- in cash or Rs.1200/- by NEFT. Admission forms completely filled-in are to be submitted to the college at the time of admission.

Eligibility

The applicant have to pass the Higher Secondary Examination under West Bengal Council of Higher Secondary Education (WBCHSE) or it's equivalent examination from a recognised university/ board in any stream with English as a subject.


